Both the covers must be enclosed within an outer main envelope superscribed with the tender number. Bidders shall quote their best prices for the configurations in the Price Bid document. The Purchase Committee will evaluate the technical specifications and the price bid of the technically confirming vendors will only be opened.
2	The bidder shall be a Company registered under the Companies Act, Partnership Firm, LLP, or Proprietorship Firm and shall have been in operation for a minimum period of Five (5) years. Self-attested copies of Registration Certificate, Certificate of Incorporation, GST Registration Certificate, and other relevant statutory documents shall be submitted along with the bid.
3	Detailed OEM Product Datasheets and Technical Brochures of the offered All-in-One Desktop Computer model shall be uploaded along with the bid. The purchaser reserves the right to verify the specifications from the OEM's official documentation. Any discrepancy may lead to rejection of the bid.
4	The OEM's official datasheet and product webpage for the quoted model shall be publicly available. The bidder shall provide the OEM website link(s) for verification of technical specifications.
5	In case the bidder is not the OEM, a Manufacturer Authorization Form (MAF) specific to this tender shall be submitted. The authorization shall include the OEM's name, address, contact details, and shall be signed by an authorized signatory of the OEM.
6	The OEM of the quoted All-in-One Desktop Computer shall have a direct presence in India for at least Ten (10) years with an established sales and service network. Documentary evidence shall be submitted, if requested.
